Fire depts. get \$29,932 in grants

Cameron Parish Planning & Development has secured another \$29,932 in grant funding for fire protection in the Parish. Three Cameron Parish Fire departments - Cameron, Creole, and Johnson Bayou - were awarded grants through the Volunteer Fire Assistance Hurricane Supplemental program. The allocation is as follows:

Cameron-Fire District No. 1: \$10,000
Creole-Fire District No. 7: \$9,182

Johnson-Bayou Fire District No. 10: \$9,750

Ernie Broussard, Parish Planner & Executive Director of Planning & Development states, "Not including the \$31 million that the state has allocated for coastal restoration, we are pleased to add these funds to our ever-expanding funding options for the Parish that now total some \$90 million in received and pending applications. I'd like to commend the staff's effort in this initiative, with special recognition to Miss Amanda Evans, who was tireless in this effort."

Cameron and Johnson Bayou Fire Departments plan to purchase breathing apparatuses (air packs) with the grant monies. Creole Fire Department plans to purchase a Cascade system, which will enable them to refill their air packs.

The VFAHS program is a 50/50 matching grant that is funded through the Volunteer Fire Assistance (VFA) program from the United States Forest Service (USFS). The program is administered through the Louisiana Department of Agriculture and Forestry, Office of Forestry.

Creole home being built to withstand 200 mph winds

In the aftermath of Hurricane Rita, new and varied home building concepts are being implemented in lower Cameron Parish to resist the effects of future hurricanes.

From elevation techniques to wind resistant structural designs, homeowners who have decided to rebuild are looking for ways to assure themselves that their new home will survive another Rita, or worse.

One such homeowner is Steven Landry, of Creole. His new home is built atop reinforced sixteen inch concrete

pilings, a foot above base flood elevation. The home is made of steel and insulating foam, and is engineered to withstand 200 mph winds.

The sills and floor joists are the only wood in the main structure, and the joists are attached to the sills with hurricane straps every sixteen inches.

Each exterior wall panel is strapped to the sills and roof system, and the sills are attached to the pilings with half inch J-bolts imbedded in the concrete.

The unusual steel roof trusses fill the entire attic space and provide great strength for the roof.

Contractor Ricky Landry says the modular wall system is easy to install, and he expects to have the house completed in 60 days. The hard foam walls come with electrical hardware already in place, which Landry says makes the cost of the home comparable to conventional construction.

According to the contractor, this type house was designed in Florida after a series of bad storm seasons, and models there have withstood subsequent hurricanes. The homes have also been built in Mississippi and New Orleans.

Folks and Memories

In 1891, my father, Will Block, and his brother, Martin Block, both of Port Neches, often sailed their sloop from Sabine Pass to the Mermentau River. Uncle Martin was engaged to Sally Crain, whom he later married, of Big Pecan Island, and dad was engaged to Jennie Sweeney of Grand Chenier.

However, a week before Jennie's wedding, she became ill with double pneumonia and soon died. Her youngest sister, Sarah Jane Sweeney, who was my mother, was only seven years old, and she recalled having sat upon Will Block's lap a couple of times prior to her sister's death. However, Sarah Jane was not to see Will Block again for 25 years, long after she had moved to Nederland in 1906.

Each of them was destined to marry and raise a family, my mother having one son by her first marriage, and my father to sire eight children by his first wife. However each spouse died early in 1917, about the beginning of World War I; and my mother, needing to support herself and son, soon found a job at Texaco's asphalt roofing plant in Port Neches.

Suddenly needing a home in Port Neches, she heard that Will Block had a place for sale on Port Neches Avenue. She drove her buggy down to the Will Block farm, seeing him again for the first time in 25 years. Dad sold her the house for \$500, she paying half the price to him in gold, and then executing a promissory note to be paid off at the rate of \$10 a month. And each month, following her Texaco payday, she dutifully rode her buggy to the Will Block farm, eventually to make her 24th and final payment of \$10.

Her payment at the end of May, 1919, being her last one, she sat patiently while Will Block wrote out and handed her a receipt, which read "Paid in Full." Then Will Block asked her, "Jane, will you marry me?"

My mother was stunned, almost to the point of fainting, but she regained her composure after a moment and told dad, "I will let you know tomorrow, Will."

Mama had already been warned that she would lose her job as soon as the plant employees began returning from the war. So she promptly returned to tell Will Block that she would marry him.

However, she never once let him live down the fact that he had waited to collect the final payment before popping the question.

Their marriage lasted for 14 years, until my father's death, during which years mama gave birth to two sons and a daughter, the latter in 1930, when she was 46 years old and my father was 60.

Mama always bragged that she could pick 300 pounds of cotton in a day, and in fact had proved it several times at Grand Chenier. Perhaps she felt she had to do it again even though she was nine months pregnant. On May 16, 1930, mama and I worked 12 hours in searing heat, and I called her "Mrs. Five by Five," because she was 5 feet wide and 5 feet tall.

All day she dropped seed potatoes in the field, and about every ten minutes, I had to refill her apron since

she was unable to bend over to empty the sack. The next day her water broke, and she gave birth at home. It was truly a miracle that she had not given birth in the field.

WEIGHTED VOTE PLAN INSTATED

U. S. District Judge Edwin

Hunter Monday ordered that a weighted vote plan be put into effect immediately for the Cameron Parish Police Jury and that the Jury present to him within 60 days a plan for the permanent reapportionment of the parish.

Judge Hunter also ordered the jury not to make any changes in its present officers, committees or parish boards other than filling vacancies until the new reapportionment plan is approved.

The judge indicated that he did not intend to order the reapportionment put into effect until the 1975 elections but warned that he could order new elections immediately if events in the parish warranted them.

Monday's court action was the result of a suit brought last Thursday by the two Cameron Parish Police Jurors, Charles Riggs of Hackberry and Norman McCall of Cameron, stating they represented 55.38 percent of the population of the parish but only had two of the six votes of the jury.

Judge Hunter agreed with the plaintiffs pointing out that voters in Ward 3 of Camron Parish had only one-sixth of the representation of those in Ward 1.

He termed this "the gross-est of disparagement" and refused to grant a request by the four other members of the police jury for a 60 day period in which to present a reapportionment plan with the same voting system in effect.

"The law seems clear to me; I don't know what there is to fuss about." He indicated that Cameron was the last parish in the state to be reapportioned.


The judge said that if it appears in 30 days that no reapportionment plan can be agreed on, he will name R. W. Farrar, federal magistrate of the court, to assist.

Free and reduced school meals program announced

Cameron Parish School Board has announced its policy for free and reduced price meals served under the National School Lunch and School Breakfast Programs.

All schools and the central office have a copy of the policy, which may be reviewed by any interested party.

The chart above shows the family size and annual income criteria to be used for determining eligibility.

Children from families whose income level is at or below the levels shown are eligible for free or reduced price meals. Application forms are being sent to all homes, along with a letter to households.

To apply for free or reduced price meals, households should fill out one application for the household and return it to the school. Additional copies are available at the principal's office in each school.

Applications may be submitted at any time during the year. The information provided by the household is confidential; it will be used for the purpose of determining eligibility. Information may be verified at any time during the school year by school or other program officials.

For the school officials to determine eligibility, each household that is now receiving Food Stamps or that is on the Family Independence Temporary Assistance Program (FITAP) must provide its Food Stamp case number or FITAP number as well as the signature of an adult household member.

All other households must provide the following information on the application: names of all household members; the social security number of either the parent/guardian who is the primary wage earner, or the adult household member who

signs the application, or a statement that the household member does not possess one; the amount of income (before deductions for taxes, Social Security, etc.) each household member receives; how often the person receives the income; where it is from, such as wages, retirement, or welfare; and the signature of an adult household member certifying that the information provided is correct.

If a household member becomes unemployed or if the household size increases, the household should contact the school. Such changes may make the children of the household eligible for meal benefits.

Foster children who are the legal responsibility of a welfare agency or court may be eligible for benefits. If a household has foster children and wishes to apply for such meals for them, the household should contact the school for more information.

School Food Authorities that use direct certification benefits should add the following paragraph with appropriate changes:

Households that receive Food Stamps or FITAP benefits are not required to com-

plete an application. School officials will determine eligibility for free meals based on documentation obtained directly from the Food Stamp/FITAP office, which will certify that a child is a member of a household currently receiving Food Stamps or an assistance unit receiving FITAP benefits. School officials will notify households of their eligibility. Households who are notified of their eligibility but do not want their children to receive free meals must contact the school. Food Stamp and FITAP households should complete an application if they are not notified of their eligibility by Sept. 26, 2007.

Under the provisions of the free and reduced price policy, Mona Theriot and Karen Richard will review applications and determine eligibility.

If a parent or guardian is dissatisfied with the ruling of the official, he may wish to discuss the decision with the

determining official on an informal basis. If the parent wishes to make a formal appeal, he may make either an oral or written response





Chenier Ecology

This month's article was sparked by a couple of phone calls questioning the safety of consuming fish with worms in the flesh.

Spaghetti worms are common parasites of saltwater fish in the Sciaenid or drum family, which include speckled and white trout, black drum, redfish and croakers. Most commonly known as spaghetti worms, each fish actually has a specific parasite which prefers its flesh. Most common in sea trout is *Pseudogrillotia pleistacantha*. Finding worms in their freshly caught fish fillets can be quite unsettling to some fishermen. However, they pose no human health risk.

In speckled trout the worms are most commonly found in the middle of the fillet below the dorsal fin, while in black drum they are more commonly found near the tail end of the fillet. While the idea of worms in fish is unappealing, cooking kills them. No human infections have

been recorded, and researchers have been unable to infect warm-blooded animals with the parasite. Although not necessary, some fishermen prefer to remove the parasite by squeezing the end of the worm between a knife blade and the thumb and pulling.

Spaghetti worms are actually parasitic tapeworms of sharks, which are using the trout or drum as an intermediate host.

The cycle begins with eggs produced by an eight-inch long adult worm living in a shark's intestine. After being passed into seawater, the egg hatches into a tiny swimming larva called a coracidium. If this larva is eaten within two days by a small marine crustacean like a copepod, it develops into another stage called a proceroid. At this stage some uncertainty exists as to what happens. The copepod may be eaten by a trout, passing the larval worm on to the trout. However, since small animals like copepods are seldom eaten by larger trout, and since few trout less

than 10 inches long have spaghetti worms, another host is suspected.

More than likely, a small bait fish like an anchovy eats the copepod and it in turn is eaten by the larger trout. In any case, once the larval worm is in the trout's digestive tract, it tunnels its way into the trout's flesh where it may live for several years. The life cycle is completed when a shark eats the trout and serves as host for the adult worm.

Research has shown that approximately 40 percent of Louisiana and Mississippi speckled trout are host to spaghetti worms, with an average of between one and two worms occurring per fish.

The number of trout carrying worms seems to be directly related to the characteristics and quality of the water in which the trout live. In general, the saltier the water and the less polluted it is, the higher the levels of infection. This may be due to either one of the intermediate host's or the larval worm's needs for saline, unpolluted waters.

Another interesting fact is that once a trout becomes host to one or several spaghetti worms, it seems to develop immunity to further infections. If this were not the case, large, old fish would

have many more worms than a 12- or 14-inch fish.

Cameron Outdoors

FISHING REPORT

Thunderstorms have returned but dodging these storms is still paying off for the Big Lake anglers. Good catches of speckle trout are being taken, 2 to 4 pounds. Some anglers are boating their limits.

I talked to three anglers who had 40 trout on a half day fishing and in between thunderstorms. The south end of the lake towards the weirs is still producing.

Most trout are being taken on leadhead with plastic, as well as redfish, but I got to throw a heavy spinner and do quite well. The wind on the lake has been blowing 15 mph or over and makes it a little rough, but overcast skies still see the fish turn on.

Topwater baits work well early mornings and late evenings, but a little slower than plastic and we could see a change with all the rains, as there's sure to be lots of freshwater coming down to the lake.

This water flowing to the Gulf makes it dirty, so anglers are having to go further out to see clearer water.

REDFISH CHALLENGE

The Cameron Saltwater Fishing Festival to be held at the Grand Chenier state park Aug. 3 and 4, will have a redfish challenge added this year. It's a team format, one or two persons, but only two fish per team can be weighed daily, alive. Dead fish will be weighed but will be penalized 8 ounces per dead fish, taken off total weight. A legal redfish must be in the slot from 20 inches to 27 inches in length. Fish under 20 inches or above 27 inches will not be weighed.

This is a separate entry from the other divisions, running at the same fishing and weigh-in times, so you have to register for the redfish challenge and have your stub to weigh-in. Entry fee for this event is \$100 per team. Places will be determined by adding the total weight of both days catches and the largest weighed will determine the placing.

Prize money is first place team, \$500; second, \$300; and 3rd, \$100. If there are at least 25 teams entered, an extra \$200 will be added to each team placing 1st, 2nd, and 3rd.

All public waters open to fishing in Cameron, Vermilion and Calcasieu Parishes and the Gulf of Mexico adjacent to these parishes obey all state and federal regulations, stay 50 yards away from another contestant's boat, no alcohol or alcoholic beverages can be consumed by entrants while

fishing during official hours or until team has weighed in.

ADDED ATTRACTION

As an added attraction this year there will be a big fish money bingo. Ping pong balls for 1st, 2nd and 3rd place fish from each fish category in each division will be added to a hopper. Three ping pong balls will be drawn from the hopper from each fishing division (offshore, bay and surf and junior). The first ball drawn for each division with the fish and place (example: croaker/1st place) will receive \$200; second ball drawn for each division with the fish and place (example: garfish 2nd place) will receive \$300. You have to place first, second or third in a fish category to be eligible for a big fish bingo money prize. You also have to be present at the big fish bingo to win prize money.



The bass are holed up closer to the water by the lake since Rita, so if you're going to catch bass, you have to travel.

There were no choupique caught, a few redfish and bass fishing was slow. There were only four teams that fished. Carl Broussard and Johnny LeDoux took first place stringer with 5 bass weighing 7.70 and second place largest bass of 1.94. Second stringer was Corey Broussard and Todd Conner 7.00 and third place largest bass; third was J. M. Boudreaux and Richard Duhon, 6.72 and first place largest bass weighing 2.02 pounds. Fourth was Ricky and Laken Canik, 4.28 and their largest bass was 1.08 pounds.

PUBLIC HEALTH - SANITARY CODE SEWAGE DISPOSAL

Responsible Parties:

A person who owns, operates, manages, or otherwise controls any premises shall provide for sewage disposal in a manner which is in compliance with this Code.

Discharges:

A person shall not directly or indirectly discharge, or allow to be discharged, the contents or effluent from any plumbing fixtures, vault, privy, portable toilet, or septic tank, into any road, street, gutter, ditch, water course, body of water, or onto the surface of the ground.

Land Application:

No sewage sludge or sewage treatment effluent shall be applied to land for treatment, disposal, irrigation or other purposes without a permit from the state health officer.

Violations; penalties:

Any person who violates the provisions of this article shall be liable in damages to the Cameron Parish Police Jury, as well as for any personal injury or property damage, including environmental damage that results from such violation.

Any person who violates the provisions of this article, or any permit issued hereunder shall, in addition to any other penalty or remedy provided hereunder or by any law, be guilty of a misdemeanor punishable by a fine of five hundred dollars (\$500.00) or thirty (30) days in the parish jail or both, at the discretion of the court. Chapter 14 MOTOR VEHICLES AND TRAFFIC

SEC. 14-50-A Stopping, parking, or standing upon the highway shoulder; driving upon the highway shoulder.

A. No person shall stop, park, or leave standing any vehicle on any parish road shoulder when such stopping or parking on the highway shoulder shall obstruct the flow of traffic or is a hazard to public safety, unless such stopping, parking, or standing is made necessary by an emergency, except:

(1) By any public utility personnel or public utility equipment engaged in the operation of the utility business, public vehicles owned by public bodies which are engaged in the conduct of official business, or privately-owned vehicles which are engaged in services authorized by the local government authority.

(a.) In case of an emergency, the driver of a vehicle may lawfully operate the vehicle on any parish road shoulder in accordance with the normal standards of prudent conduct to protect himself or others from harm. When the emergency ends, the vehicle shall not be operated on the parish road shoulder.

Violations; penalties.

Any person who violates the provisions of this article, in addition to any other penalty or remedy provided hereunder or by any law, be guilty of a misdemeanor punishable by a fine of five hundred dollars (\$500.00) or thirty (30) days in the parish jail or both, at the discretion of the court. Each day a violation continues shall constitute a separate offense.

Kids who stutter have a lot to say, and friends can show them how in "Stuttering: For Kids By Kids", a DVD starring real kids who stutter now available at the Cameron Parish Library.

Many children who stutter have never met anyone else who struggles with the same disability. But in this new video from the Stuttering Foundation, they meet other kids who recount how they handle challenges such as teasing, speaking out in class, and teaching others about stuttering.

The children, who range in age from first-graders to high school students, offer frank

and sometimes differing views of stuttering.

For example, Matthew, age 10, says about his speech difficulties, "It's no big deal," but Kate, age 9, worries about talking, what is going to happen next and whether or not she'll stutter. Arianne, age 14, says, "The hardest part about stuttering is to get through it and stay in there when you're stuck." Umang, age 12, agrees, "Sometimes it gets kind of annoying when you want to say something and you can't. I also get worried what other people might think if I do stutter and wonder if I'll be able to get out of my blocks and things."
