Most parish taxes will remain same

Most parish tax rates will remain unchanged, but a few will be rolled up following action taken at a special voting meeting held Monday night by the Cameron Parish Police Jury.

With no public comment given at the public hearing, jurors voted to leave most millages at last year's level, with four exceptions. Two fire districts that received major damage from Hurricane Rita, Hackberry and Cameron, asked to be rolled up to provide funds for rebuilding. Hackberry Fire Protection District #1 will increase from 4.52 to 4.71 mills. Cameron Fire Protection District #9 will increase from 2.35 to 2.54 mills.

Also, two parishwide taxes, the garbage fund and the general fund, will be raised. With solid waste disposal expected to rise drastically when federal debris removal ends, the parishwide garbage tax was rolled up from 7.55 to 7.86 mills.

The parishwide ad valorem tax that funds a variety of parish offices and operations of the Police Jury was rolled up from 3.57 to 3.72 mills. This general fund typically brings in about \$500,000 a year. The increase will add about \$20,000.

Rates were also set for two sinking funds, used to pay off bond issues. The Lowery Fire Protection District bond issue tax was set at 4.4 mills, and the Creole Fire Protection District bond issue tax was set at 7.6 mills.

The parish awarded the bid for three 14 yd. dump trucks to Martin Truck Center, the sole bidder. Delivery is expected in two to three months.

NEW EQUIPMENT

New equipment is arriving in the parish to replace that which was destroyed by Hurricane Rita, Police Jurors learned Monday night. The parish has purchased bush

hogs, lawnmowers, dump trucks, slope mowers, backhoes, tractors, and pickup trucks. Some of the equipment has not been delivered yet, but those pieces that have arrived have been distributed to the various road crews. The lack of equipment has made it difficult for parish crews to deal with cleanup and repairs as surviving machines have had to be shared around the parish.

Several Cameron residents asked the jury to try to improve drainage in the populated areas of the town, citing standing water and yard flooding due to recent heavy rains. Mud and debris from Hurricane Rita is clogging culverts, filling ditches, and clogging drainage throughout lower Cameron Parish.

Ridgecrest Subdivision resident Julie Burleigh expressed concern that the standing water is breeding mosquitoes and will soon attract snakes into neighborhoods. Another resident was concerned about children playing in stagnant water.

OEP Director Clifton Hebert reported that all research on the parish-wide drainage situation has been completed and forwarded to FEMA, in hopes that the job will be tasked to the Corps of Engineers. If that happens, work can begin soon, but the Aug. 30 deadline for full funding may cut the work short.

A project worksheet for FEMA reimbursement is also being prepared in case the parish has to contract the work itself. If so, the parish will be responsible for 10% of the cost, which could be in the millions.

Jurors recommended that any residents who have serious problems with drainage call 905-1214 and ask to have a work order made. The road crews will try to get to the worst areas first, but there is only one ditch digger being shared throughout the parish. Crews have been busy putting

Schools to open here Aug. 21st

Cameron Parish schools will open on Monday, Aug. 21 and meetings of parents and teachers are being held this week to establish where students will be attending.

Students who attend Grand Lake, Hackberry and Johnson Bayou high schools will attend those schools as in the past.

Students of South Cameron High, South Cameron Elementary and Cameron Elementary will attend school in temporary buildings located at the South Cameron high site. There will be 44 new classrooms on the site.

Johnson Bayou students will attend school using the portable classrooms that were used in the spring semester at Hackberry. The cafeteria has been restored and the gym is expected to be restored by October.

All schools will operate on a regular five days per week schedule.

The School Board was able to retain all employees after the hurricane.

Road Home offers aid to residents

The Road Home provides financial assistance for homeowners to get back into their homes and creates powerful incentives to rebuild rental properties so that everyone can have a chance to come home.

The program provides grants of up to \$150,000 to help homeowners who want to repair or rebuild their homes, take a buyout and relocate within the state or sell their homes to the state and move out of Louisiana.

When registering for The Road Home, homeowners will be asked to provide information about their home, including:

- Residents' name
- Residents' current address
- Location of the damaged or destroyed home
- Contact phone numbers
- Mortgage information
- Status of any insurance settlements
- Information about any FEMA of U.S. Small Business Association (SBA) disaster assistance or applications for disaster assistance.

West Nile found in one sample in the parish

A new brood has hatched from last week's heavy rains. Our inspectors are checking the entire parish everyday to see which areas have the highest populations. We are going to be spraying every night that the weather permits with our trucks and plane until mosquito populations are reduced to tolerable levels.

This week there have been six human cases of West Nile Virus reported in Louisiana. There have not been any reported in Cameron Parish. We are collecting samples of mosquitoes every week throughout the entire parish that are submitted to the LSU veterinary laboratory testing for West Nile, Eastern Equine Encephalitis, and St. Louis Encephalitis.

We are also sending in dead blue jays, cardinals, and crows that are found in residents' yards. We have sent in over 150 samples so far and one blue jay.

So far we have had only one sample of mosquitoes test positive for West Nile. This was in the Hackberry area. All samples submitted last week revealed negative results. If we have an indication that the virus is active in any area of the parish we will step up control efforts to try to keep it from spreading into our population.

If you find a dead blue jay, cardinal, or crow in your yard that appears to have died from natural causes, is not covered with ants, and has not begun to decay or smell, you can call the mosquito control office at 905-5941. We will send someone to pick it up and submit it for testing. You should not touch the bird with

your bare hands.

When you call the office, we will give you instructions for safe handling of the bird. No other species will be collected because they have been found to have a much lower death rate from West Nile compared to blue jays, cardinals and crows.

West Nile is now a well established disease ranging across the entire country. West Nile activity peaks in the summer and early fall, and will likely show up every year because it occurs naturally in bird populations. Mosquitoes can only become infected by biting a sick bird. Once the mosquito is a carrier for the virus, it can transmit the virus to birds, humans and horses. Humans and horses are dead end hosts. This means they cannot transmit the virus any further.

The most common way for a human or horse to get

infected is from a mosquito bite from an infected mosquito. Out of all the people bitten by an infected mosquito, less than one percent will develop the serious symptoms including fever, headache, muscle pain, swelling of the brain, loss of vision, and paralysis. Most people will not develop any symptoms at all. People over 50 are at the highest risk of developing serious symptoms.

The best ways to protect yourself from West Nile Virus include wearing long protective clothing and repellents when mosquitoes are active, empty any container that holds water around your house at least once a week, make sure all window screens are in good working order, and limit your exposure to mosquitoes at dusk and dawn when populations are most active. Horses should be given all vaccines available for West Nile Virus and Eastern Equine Encephalitis.

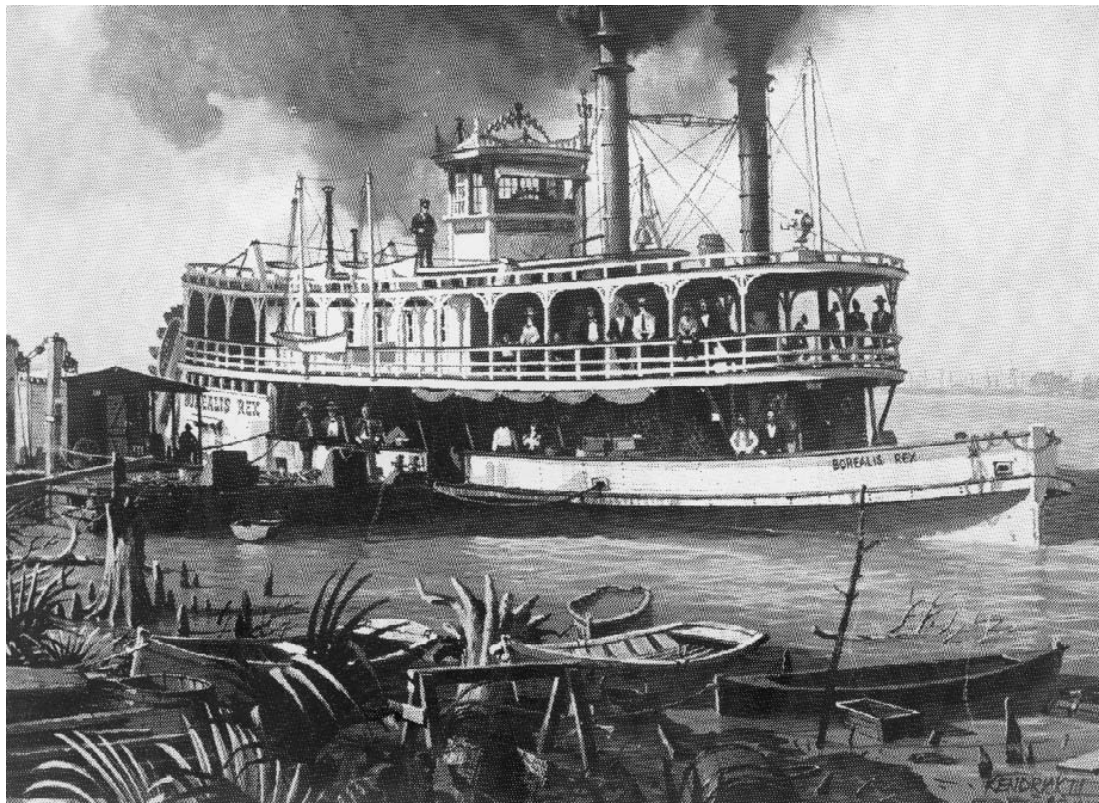

FROM 1910 to 1931 the old Borealis Rex steamer was the chief means of transportation between lower Cameron Parish and Lake Charles. This painting of the old boat was featured on the cover of the Cameron telephone book a few years ago.

Old Rex remembered

(EDITOR'S NOTE—Reader Nell Colligan of Lafayette (formerly of Cameron) ran across this in the 1984 copy of Pirate's Pantry published by the Lake Charles Junior

League. She thought the Pilot readers would be interested in this early Cameron Parish means of transportation.)

A stately sternwheeler, the "Borealis Rex" was for many years the only means of transportation between Lake Charles and Cameron.

Carrying mail, passengers, and freight the steamer's arrival each Wednesday created quite a stir in the coastal town. Settlers paddled their pirogues, rode horses, or walked to greet the "Rex" on "Boat Day."

Built before, 1900, the riverboat once plied the waters between Natchez, Mississippi, and New Orleans. But in 1910 it was purchased by Calcasieu Captains Ben Moss and A. B. McCain, who put it into service between Cameron and Lake Charles.

Fed with pine knots, the steamer had elegant state-rooms, a dining room, and an upper and lower deck. Since Cameron had few trees, wood was an important cargo.

The boat made three trips a week, arriving in Cameron on Saturdays, Wednesdays and Mondays with intermediate stops at Vincent's Settlement, the Calcasieu Post Office, Hackberry and Big Lake.

Church groups and parties frequently chartered the "Rex" for pleasure excursions, and no trip to Lake Charles was complete without an outing on the steamer.

On Aug. 6, 1918, the "Rex" sank at a point below Prien Lake, victim of the same hurricane which demolished the city of Lake Charles. When it was raised, divers found that the upper deck had been swept away in the storm.

Repaired and returned to service, the sternwheeler continued to transport mail and passengers until completion of the Sulphur-Cameron highway in 1931.

Anchored for many years at the foot of Pujo Street, the old riverboat was finally sold at a sheriff's sale for delinquent taxes to a wrecking company for \$110.

Southwest La. ahead in hurricane recovery

State Rep. Charlie DeWitt said Southwest Louisiana is recovering more quickly than other areas hit by Hurricane Katrina.

DeWitt, a Democrat from Alexandria and former state House speaker, spoke Tuesday to the Kiwanis Club of Lake Charles.

"It's amazing that we really haven't gotten as far as we should, and the 29th of this month will be one year," DeWitt said of the Katrina recovery.

DeWitt - who has family in

Southwest Louisiana, including Hackberry - said the area is "far way ahead of everything that is happening in Orleans, St. Bernard."

He said that he understands that Hurricane Rita is often overshadowed by Katrina, and he figures that is unlikely to change.

"If we wouldn't have had Katrina, Rita would have been first," he said.

Despite that, he said, Southwest Louisiana has secured its fair share of state capital outlay money for things like road improvements, building construction and port upgrades.

FIRST RICE CUT

The first of the 1973 crop of rice was scheduled to be cut in Cameron Parish this week. County Agent Clifford Myers said that Dick Smith of the Klondike area was to cut some Vista and Blue Bell rice this week, with other farmers to follow suit within the next couple of weeks.

The rice in the Sweetlake area is a little later than that at Klondike, Myers said, because many of the Klondike farmers have facilities to pump off their fields while those in the Sweetlake area do not.

GATOR SEASON—1973

A 19-day hunting season for alligators in Cameron and Vermilion parishes was approved Tuesday by the Louisiana Wildlife and Fisheries Commission.

This will be the second year for an alligator season. Last year the season was limited to Cameron Parish.

Despite opposition to the season from some conservation groups on the basis that the alligators are "an endan-

gered species," Richard K. Yancey, assistant commission director, said that they are very plentiful along the Louisiana coast.

"There are 75,000 alligators living within the hunting area," he said. "A hunting season is essential to keep them in balance."

Declaring last year's experimental hunting season a full success, the commission made this one six days longer and expanded it into two parishes.

Last year's hunt was confined to 750,000 acres of Cameron Parish swamp. The 59 hunters caught 1,350 alligators. Their hides sold for about \$55 each, or \$8 a foot.

WORK BEGINS ON BRIDGE

Work began last week on the high-level bridge across the Intracoastal Waterway at the Ellender crossing north of Hackberry, according to John Boagni, district of highways.

The new bridge will go up about 300 feet east of the present pontoon bridge on Louisiana 27 between Sulphur and Hackberry.

The bridge will be a vertical-life-span structure. When the bridge is open to highway traffic, water traffic will have about 50 feet of vertical clearance. In the event taller vessels are moved on the waterway, the center span can be raised to provide 135 feet clearance for water traffic.

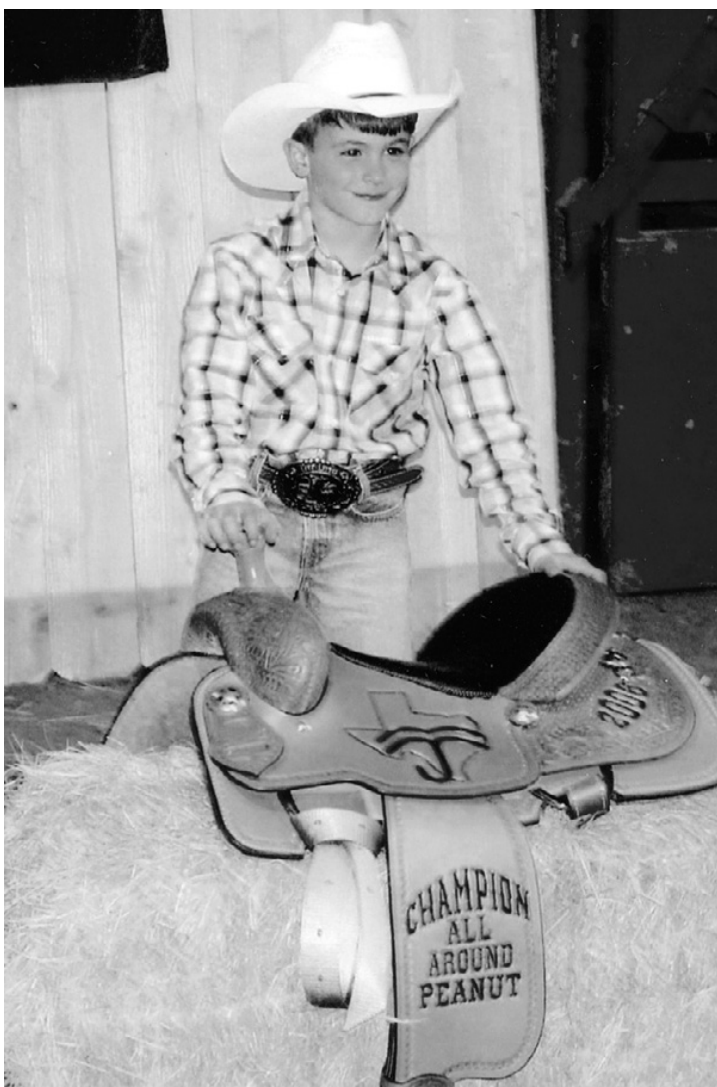

in new culverts in Grand Lake for all the people trying to move trailers in, according to Juror Darryl Farque.

The dump trucks needed for mud removal have been ordered, but will take 60-90 days to arrive. Juror Scott Trahan said another problem is finding a place to dispose of the spoil, since it contains debris and no one wants it on their land. One site has been secured in Creole, he said. Resident Mona Kelley suggested that even cleaning the ends of the culverts helps

improve drainage.

Creole resident Jay Rutherford asked the Jury to go on record stating that expropriation and eminent domain will be excluded from all parish planning "now and in the future." Parish planner Ernie Broussard said there are no projects involving those issues being planned at this time, but he advised the Jury that it would "not be wise to eliminate a power you might one day need." Jurors declined to place the issue on the agenda, wanting to leave that avenue open.

Rutherford said he had a "general fear" that "unscrupulous investors and real estate vultures" may

come in and try to take people's land. Juror Steve Trahan responded that real estate people and investors cannot take anyone's land.

The parish's Coastal Zone Management Director, Miles Hebert, asked the Jury to consider restricting the permitting of sand excavation along the coastal cheniers. He said the state is spending a lot of money on restoration of the coastal barriers, the first line of defense against storm surge, and the parish is allowing pits on the cheniers.

During the storm, Trosclair Road and Hwy 82 in Grand Chenier were almost breached due to sand excavation pits. Coastal zone management regulations require the parish to "discourage, and to the maximum extent possible, disallow" such excavation, Hebert said.

The jury will also look into designating routes for heavy trucks to use during building projects, where alternate routes are possible. Hebert said road damage can be reduced with the use of such routes in the building permit.

Parish Planner Ernie Broussard reported that the field has been narrowed to two companies who were interviewed last week for the job of assisting with long-range planning. He expects to make a recommendation at Monday's regular Police Jury meeting.

Remember the old token Children will need vaccine

Two little Cameron Parish boys, Ben Welch and Caleb Jeffers, learned a history lesson first hand this week when they found an old tarnished coin in an old trash dump. It had a triangular hole in the center.

When steel wool was applied to it the coin showed up plainly, "Luxury Tax" across the top, "Token Louisiana" on the bottom, and the figure 5 on each side of the coin.

The coin is the descendant of a 1936 state law. During the depression years, the Louisiana Legislature, in Act 75 of the 1936 legislature, passed a "Luxury" tax, which went into effect Oct. 1, 1936, and called for a two percent levy on many items sold for retail. The act called for the coining of tokens.

In its regular session of 1938 the state legislature passed the Public Welfare Revenue Act, a one percent sales tax.

It provided for the coining of Welfare tax tokens. At the same time it repealed Act 75 of 1936, effective July 1, 1938, and provide for redemption of

the "Luxury Tax" tokens.

One of the platforms in candidate Sam Jones 1939 campaign for governor called for the abolition of the welfare tax and simultaneously of the tokens.

With Jones as governor, the state collector of revenue was empowered by the 1940 legislature to redeem the Welfare Tax tokens, and, in fact, the collector's office had held in escrow \$93,000 for redemption.

Act 82 of the 1940 regular session abolished the Welfare Tax and allowed citizens until March 31, 1941, to redeem their tokens.

The tokens were issued in 1938 in one-mill and five-mill denominations. One-mill tokens were made of aluminum; five-mill tokens were of brass.

A total of 57,000,000 tokens were minted, 49,000,000 being one-mill pieces, at a value of \$87,000.

A purchaser would pay one-mill on purchases from 5 to 14 cents, two-mill purchases from 15 to 24 cents and at similar rates up to a dollar, where the tax reached a penny.

This collection item today is a contact with a time when the Louisiana sales tax was only one percent.

Funds allocated for housing

To meet the tremendous need for housing in hurricane-impacted areas of Louisiana, USDA Rural Development has allocated over \$639 million in supplemental funding for single family housing loans and grants for very low to moderate income individuals or families in disaster-declared and contiguous parishes.

Mississippi, Alabama, Texas, and Florida also received single family housing disaster supplemental funding.

USDA Rural Development offers home financing programs for qualified low-to moderate-income families, as well as home repair funding programs for very low income home owners. Eligibility for these programs is primarily based on income, repayment ability, and acceptable credit history. Some of the benefits of these programs include 100% financing, no down payment, no Private Mortgage Insurance (PMI), extended financing periods, and fixed rate financing.

This disaster supplemental funding is available in most south Louisiana Parishes including Cameron and Calcasieu.

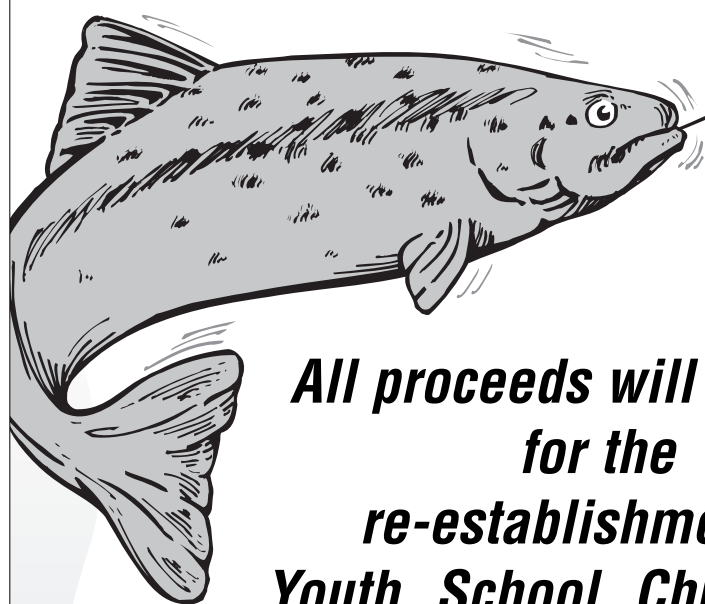

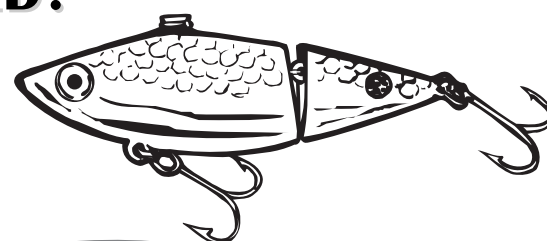

HUNTING NEWS

The Louisiana Wildlife and Fisheries Commission has said it will keep the two waterfowl zones (east-west) through the 2110 season. Over half who sent in their surveys wanted to keep our current season with two hunting zones. Again all this goes beyond the U.S. Fish and Wildlife Services. Dates will be set this week by our commissioners at their Aug. 3 meeting.

Reports are that plenty of water in the last two years in the duck breeding grounds has really paid off, as most species of our duck population have increased.

The scaup species continues to go down as well as the American Wigeon, but all other species have gone up, with shovelers, blue and green-winged teal, canvass-backs, gadwalls, and red heads doing the best in years. The total number of breeding ducks are at 36.2 million, that's 14 percent over last year, and 9 percent over the long-term average.

The breeding population for mallards is 7,277,000, up 8 percent; gadwall, 2,825,000, up 30 percent; red head, 916,000, up 55 percent; greenwinged teal, 2,587,000, up 20 percent; blue-winged teal, 5,860,000, up 28 percent; shovelers, 3,680,000, up 2 percent; and pintails, 3,386,000, up 32 percent. Scaup is 3,247,000, down 4 percent, and wigeon, 2,171,000, down 2 percent.

The Commission has also set tentative dates for the 2006-07 mourning dove and early bird migratory bird hunting season. The mourning dove season will have 70 days in three splits: Sept. 2-10, Oct. 14-Nov. 19, and Dec. 6-Jan. 8.

This year hunters may kill white-winged doves, some-

thing we'll see for our first time, and will be included in the 12 birds aggregate daily bag limit and possession limit of 24 total birds.

The Eurasian Collared doves and ringtailed turtle doves (we call ringed necks) will have no bag limit, but you have to leave a full feathered wing and head attached, and they may be taken only when the mourning dove season is open.

The opening of each weekend (Sept. 2-3, Oct. 14-15 and Dec. 16-17) of dove season, shooting hours will be from noon to sunset. All other days of dove season, shooting hours will be a half hour before sunrise to sunset.

Our teal season is 16 days, Sept. 15-30, with a daily bag limit of 4 and possession limit of 8. Rails and gallinules will have a 70 day season opening for teal season 16 days. The Commission will set the rest of the season for rails and gallinules when they set the regular duck season.

Call to Order The meeting was called to order at 6:00 p.m. by Mr. Theriot.

Pledge of Allegiance Barbara Lou LeBlanc led the Pledge of Allegiance.

Approval of Minutes

It was moved by Ms. LeBlanc and seconded by Mr. Dupont to dispense with the reading and approve the minutes from the previous meeting. Motion carried.

Old Business Expand Lower Cameron Hospital Service District

Ms. Jones reported to the Board that a bill had been introduced to the Louisiana State Legislature which stated that no hospital in the state, from a hurricane affected parish, could reopen unless they receive authorization from the Louisiana Department of Health and Hospitals. This authorization was contingent upon need for a hospital based upon population and occupancy. This would have effectively prevented Cameron Parish from qualifying to rebuild its hospital. After contacting both DHH and our local representatives and pointing out that this bill would affect Cameron Parish, the bill was amended to exclude rural hospitals throughout the state.

Ms. Jones then reported to the Board about the meeting with the Cameron Parish Police Jury's Hospital Committee that took place on May 1st after the regular Police Jury meeting. Persons attending this meeting were Sonny McGee, Scott Trahan, James Doxey, Tina Horn, and Ernie Broussard from the Police Jury; Sheriff Theos Duhon; Clerk of Court Carl Broussard, Mona Kelly from the Assessor's Office; Jay Delafield, bond attorney; Greg Fawvor, and Jennifer Jones representing the Hospital; and finally Ray Gonzales and Tina Vidal from PACER. During this meeting Ms. Jones had outlined to all present that the District was proposing expanding the Service District to include all of Holly Beach and Johnson Bayou to the state line. We would then offer a 12 Mill tax to the new Service District for a vote. This 12 Mill tax would generate approximately \$1,200,000 for the District and this tax could be rolled back as each LNG plant became active.

Mr. McGee had stated that the Hospital Service District would have to approach all of the industries presently located in Johnson Bayou and Holly Beach to see if they opposed a new tax and hold a series of public meetings to educate all of the voters on the tax. He also said the he felt that any monies raised through taxes on industries located in Johnson Bayou and Holly Beach should be used exclusively in that area for health care

and that none of the monies raised should be used in Creole on the Hospital. As an alternative to the present plan, Mr. McGee had offered to allow the District to move across the ship channel, take in the Creole Trail LNG plant and businesses just west of the Ship Channel. Ms. Jones explained that this could be done by a majority vote of the Police Jury, but would not have to go before the voters because no one lives in that area on the West side of the Ship Channel. However, she stated that after consulting with the Assessor's office it was found that this would only bring an additional \$40,000.00 per year until the plant came online sometimes around 2010. Therefore a much larger tax would have to be passed by the voters, around 20 1/2 Mills, to generate the same amount of money. She also said that when the Creole Trail Plant came online the larger tax could be rolled back if necessary.

New Business Management Company Report

On a motion by Mr. Dupont, seconded by Mr. Nunez the Board approved the final elevation plan, site plan, and floor plan for reconstruction of the Hospital as submitted from TRC Engineers, Inc. The motion carried.

In its application, Cameron LNG requests, among other things, authority under section 3 of the Natural Gas Act (NGA) and Part 153 of the Rules and Regulations of the Commission for modifications to the liquefied natural gas ("LNG") import terminal approvals that the Commission previously granted in Hackberry LNG Terminal, L.L.C., Preliminary Determination on Non-Environmental Issues, 101 FERC ¶ 61,294 (2002) ("Preliminary Determination"); Cameron LNG, LLC, Order Issuing Certificates and Granting Requests for Rehearing, 104 FERC ¶ 61,269 (2003) ("Original Certificate Order"); Cameron LNG, LLC, Order Amending Section 3 Authorization, 111 FERC ¶ 61,018 (2005); and Cameron LNG, LLC, Order Amending Certificates and Section 3 Authorization, 115 FERC ¶ 61,229 (2006). The Commission has assigned Docket No. CP06-422-000 to this application.

In particular, the application seeks authority to expand the LNG terminal facilities previously approved: (i) to increase to 2.65 Bscf/d the send-out rate of the terminal from the previously certificated send-out rate of 1,500,000 Dth/d; (ii) to increase LNG storage capacity from 480,000 m³ to 640,000 m³ through the addition of a fourth storage tank; (iii) to increase the LNG unloading rate at each berth; (iv) on an interim basis, while the expansion facilities are being constructed, to increase to 1.8 Bscf/d the send-out rate from the previously certificated send-out rate of 1,500,000 Dth/d and (v) to modify the Btu control unit to include an option for diluting the send-out gas with an inert gas stream in addition to or as an alternative to the liquids-stripping facility previously identified by Cameron LNG in earlier applications.
