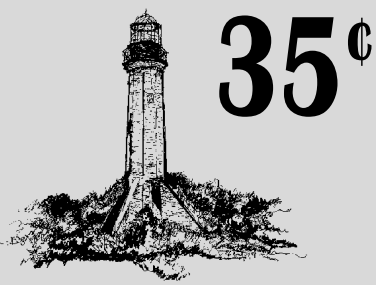
The state of Louisiana's poverty rate is 16.9%, highest among all 50 states. Almost one-third (29.8%) of the children (under 18 years of age) live in poverty in Louisiana. In 2003, the number of families living in poverty in Louisiana was 181,000.

As of the 2000 census, 12.3% of the 9,991 people in Cameron Parish are below the poverty line. Nine and one tenth percent of families in Cameron Parish are below the poverty line, 13.1% of those are under the age of 18, 14.8% are 65 and older.

In Sept. 2004, Gov. Kathleen Babineaux Blanco issued a charge to reduce poverty in the state. Four hundred volunteers from across the state were trained to organize and facilitate initial Solutions to Poverty conversations at the community level which were held in every parish in Oct. and Nov. 2004.

Dinah Landry, Tina Wolfe and Lana Miller were invited by Adren Wilson, Assistant Secretary, Department of Social Services, to participate in a workshop on July 25 regarding solutions to poverty. They will serve as co-con-

## Parish teachers get classroom allowance

As school is about to begin in Cameron Parish, help is on the way for teachers who are now preparing their classrooms. The School Board voted Monday afternoon to give each classroom teacher \$100 to help purchase instructional materials and supplies, as was done last year.

The national average for teacher out of pocket expenses is about \$500 per year for classroom supplies, decorations, visual aids, etc.

Supt. Doug Chance also reported that funds for the one-time teacher salary adjustment approved by the state legislature this spring have been received. Both teachers and support personnel will be receiving their checks in September, he said.

Chance congratulated his teachers and Cameron Parish students and parents for the test scores just released by the state. The Department of Education has reported that parish 4th and 8th graders outscored the state average on the combined spring and summer LEAP 21 results.

Parish 4th graders meeting Approaching Basis/Basic were 134, or 89%. The state average was 81%. Parish 8th graders meeting AB/B standard were 117, or 90%, with the state average being 82%.

These test results include students who did not have to take the tests because they were previously retained, students who had moved out of the parish prior to the test, and special population students. If these numbers were removed from the report, the results would be even higher, according to Stephanie Rodrigue.

Chance cautioned that there is still work to be done,

veners for the SToP Network in Cameron Parish.

since the parish did not fare as well compared to the local region. "There is still work to be done," he said, vowing to work to bring Cameron schools up in the rankings in the five parish area.

### SCHOOL SECTIONS

Several issues concerning school sections were addressed by the board. The board approved the hiring of temporary outside legal assistance on specialized areas relating to access to the School Board's 16th section lands, some of which are surrounded by other landowners. Chance explained that in earlier times, access across a neighbor's land could be agreed with only a handshake, a "gentleman's agreement."

Today, however, issues of liability and an increasingly litigious society have made things much more difficult. He cited one case which has been in negotiation since 2003 and still hasn't been settled.

District Attorney Cecil Sanner explained that even though right of way must be granted to allow access, the terms of the right of way, possibly including a fee, may need legal assistance to draft, or even litigation if the parties can't agree.

The DA's office has been working on some of these cases, but Chance said it would go faster if he could call on a specialist, possibly for just a few hours at a time. Those who lease school sections are not automatically guaranteed access by their lease, and some lessees are having trouble gaining access.

### SURFACE LEASES

The School Board receives a good income from its 16th sections, and a number of surface leases were granted by the board on Monday. Greg

Comeaux had the high bid of 56% on alligator trapping on School board owned lands not under lease or where alligator tags are allotted but not claimed by the current lessee. Other leases granted were:

The Board voted to pay for the spraying of coffee weeds on Section 16-15-14 after hearing several options for removal of undesirable plants, including tallow trees, mesquite, cactus, and bullwhips. The cost should be less than \$1300 for the coffee weed spraying. The Board will take the other options under advisement to consider whether it is worth the cost to make the property more attractive to bidders in the future.

### BID CHANGES

A vendor who had previously been awarded the bid for providing trash bags and latex gloves has lost its contract.

The company, Interboro, failed to make timely delivery of the products, so the bids were retracted by the Board and awarded to the next highest bidders, Economical (trash bags) and Lake City Supplies (gloves).

The company awarded the mowing and grounds up-keep

## Inland shrimp season to open on Aug. 15

The fall inshore shrimp season will open in Shrimp Management Zone 1, 3 and the remaining portion of Zone 2 currently closed to shrimping at official sunrise Monday, Aug. 15. The Louisiana Wildlife and Fisheries Commission approved season dates at its Aug. 4 meeting.

The closing date set by commission for these waters is official sunset Tuesday, Dec. 20, 2005, except for the open waters of Breton and Chandeleur Sounds.

Zone 1 includes Louisiana waters from the Mississippi-Louisiana state line to the eastern shore of South Pass of the Mississippi River. Zone 3 extends from the western shore of Vermillion Bay and Southwest Pass at Marsh Island to the Louisiana-Texas state line. The remaining portion of Zone 2 which will be opened to shrimping includes

those waters from the Atchafalaya River Ship Channel at Eugene Island to the western shore of Vermillion Bay and Southwest Pass at Marsh Island.

The commission authorized Secretary Dwight Landreneau to change the closing dates of the 2005 fall shrimping season if biological and technical data indicate a need to do so or if enforcement problems develop and to close and reopen all or parts of state inside and outside waters if significant numbers of small white shrimp are found in these waters.

According to LDWF trip ticket report data, Louisiana commercial white shrimp landings in 2004 totaled approximately 73.5 million pounds (heads-on weight), the second highest white shrimp landings year on record, and were valued at \$96.2 million.

## Arrests made in assault on movie film crew

An investigation into an attack on two members of the "Little Bayou" film crew on July 22 led Lake Charles police to believe the incident was a hate crime.

The movie is being filmed in Cameron Parish.

State Police have arrested two people in connection with the beating: Janice Denise Davis, 31, and Christopher Demond Jones, 19, both of 4245 Fifth Ave., Apt. B-6.

More arrests are expected.

The victims, both white men, were attacked and robbed by a group of eight black men and women, police said.

One of the suspects said the victims were targeted

because they were white, investigators said.

The incident took place downtown near the intersection of Broad and Bilbo streets in Lake Charles.

The victims told the group they had no money, but were attacked anyway. One victim was struck in the face; the other was beaten on the back with a 6-foot-long stick and knocked unconscious.

Davis has an extensive criminal history, but this is Jones' first arrest, police said.

Both were charged with armed robbery and second-degree robbery. If they are convicted of hate crimes, five years will be added to their sentences.

## ALLIGATORS GOT CRAINS STARTED

You might say that the lowly alligator was the start of the most successful industry that Grand Chenier has ever had.

It was back in 1931 that John Paul and A. H. "Sono" Crain and Burdsey Boudreaux built their first marsh buggy to be used for hunting and trapping alligators in the deep, boggy, floating turf marshes. They were living on Little Pecan Island in the eastern end of the parish across from Little Chenier.

Alligator hunting in those days was a very profitable business, according to John Paul. Seven-foot alligators were bringing a top price of \$3.50 a hide. This was the top price for any length alligator. This same alligator today could command a price of \$40, Crain said.

The first summer the Crain brothers trapped using the marsh buggies they averaged \$50 to \$60 a day and worked 5 days a week. This was "big money."

Then in 1934 the oil companies moved into the coastal areas with their shooting crews exploring for oil and they needed a way to criss-cross the vast marsh areas. The Crains furnished the marsh buggies, which was the answer, and a fleet of 40 resulted, servicing an area that covered Texas, Mississippi, Alabama and Florida, as well as Louisiana. Crain Brothers have now expanded from the marsh buggy business to servicing the vast oil industry that services Cameron Parish as well as the entire Gulf coast.

## DOXEY HOME OLDEST

The old Doxey home is the oldest home standing in this section of Southwest Louisiana and Southeast Texas. It was built around 1840 and was the first home built on Grand Chenier of dressed lumber.

This old home has never had salt water from any sea storm on its floors, not even the waters of Hurricane Audrey which left such devastation in the wake when it roared in out of the Gulf June 27, 1957.

The spot on which the house stands is the highest point on Grand Chenier. It is 11 feet above sea level. The house stand 3 1/2 feet off the ground on brick piers.

The home was built by William M. Doxey, who was one of the first settlers on Grand Chenier.

A story handed down through the family relates that when the first white settler Milledge McCall and Doxey came to the island the only person there was a shipwrecked sailor named Bill Beazley, who saved himself by clinging to mahogany table, the only stick left of the wrecked schooner. He was sleeping at night in the oak trees to keep out of the reach of bears.

The old home also housed a cigar factory in its early days, in addition to serving as living quarters, 20 years before the Civil War.

The house was remodeled and enlarged in 1890, again in 1917, and again in 1948 by the present owners, Mr. and Mrs. John Paul Crain who have preserved it and restored it to its original splendor.

The lumber used in the 1890 renovation was all cypress and the carpenters came from Abbeville.

In the 1917 remodeling the upstairs was made larger, and four bedrooms and a hall, and the staircase leading up from the downstairs entrance hall reversed. Two gables were added to the two already in the roof at the front.

## JONES EXPLAINS GIFT

Jerry G. Jones, chairman of the Louisiana Wildlife and Fisheries Commission, has issued the following statement regarding the alligator hides that had been turned over to him by the commission's Refuge Division.

"The five or six skins that I received from the Refuge Division were turned over to the Cameron Public Library and are on display in a wildlife exhibit there. The library and the exhibit is one of the focal points of attraction during the annual Fur and Wildlife Festival held each January in Cameron," he said.

Jones added that the alligator skins were examined and photographed at the library during the past week in connection with stories on the special alligator season that has been set for Sept. 5-17 in Cameron Parish.

Also placing from Hackberry were Stevie Trahan with a first in pony express, second in barrels, third in barrel pick up and tied for fourth place in pole bending; Mark Trahan, second in pole bending; Scott Kyle, third in junior flags; George Shove, third in senior flags.

## SMALLPOX SHOTS NOT NEEDED NOW

Act #332 passed by the 1972 Legislature amends the old immunization law relative to the immunization of children entering schools. This new law eliminates the requirement of smallpox vaccinations for school entrance.

Since routine smallpox vaccination has already been discontinued by a policy recently adopted by the State Department of Health, smallpox vaccinations will essentially be limited to foreign travelers and hospital and medical personnel.

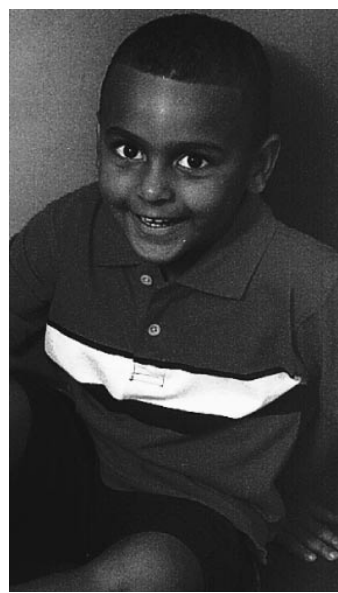

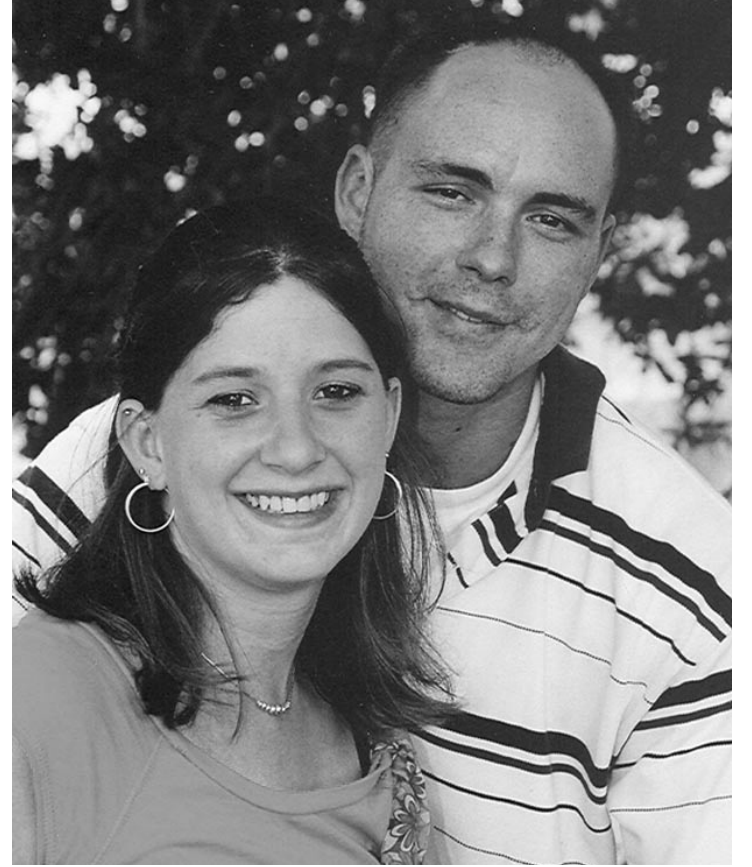

## LSU field day to teach dove management

The LSU AgCenter will host a field day on managing mourning doves in Louisiana on Aug. 20 at the Dean Lee Research & Extension Center near Alexandria.

"This is an opportunity for hunters, farmers, landowners and others to learn about land management and laws regulating food plots," said LSU AgCenter forestry and wildlife specialist Dr. Don Reed.

Reed said participants will rotate through concurrent sessions covering the status of doves in Louisiana, managing plantings of grain and grasses, legal issues of planting and manipulating crops to attract doves, and the establishment and management of native grasses to maintain dove populations.

"The unique combination of row crop diversity and pasture grasses at Dean Lee Research Station attracts doves to the station," said LSU AgCenter area forestry and wildlife agent Barry

Crain. "Plantings of millet, grain sorghum, sunflower and native grasses provide a diverse food source to attract and maintain dove populations."

In addition to Reed and Crain, presenters will include Roy Vidrine with the LSU AgCenter, Mike Olinde and Lt. Colonel Keith LaCaze with the Louisiana Department of Wildlife and Fisheries, Philip Siragusa with the U.S. Department of Interior, Fish and Wildlife Service and John Pitre and Scott Edwards with the Natural Resource Conservation Service.

The field day will begin with registration at 8 a.m. and conclude with lunch at 11:30 a.m.

Registration for the field day is \$15 if paid by Aug. 19 or \$25 on the day of the event.

Successful applicants will be notified and required to submit an additional check or money order for \$200. In the event that a hunter is unable to participate on the date scheduled, he or she may transfer his or her permit to a qualified hunter of his or her choice, as long as the total number of hunts does not exceed two for the 2005 teal season.

## Tony Jo Henry was second woman to be executed

At 12 p.m. on Nov. 28, 1942, Toni Jo Henry, also known as the "tiger woman," walked down a flight of stairs in the Calcasieu Parish jail in Lake Charles, accompanied by Father Wayne Richard; she whispered a prayer, then a word to Sheriff Henry Reid as the executioner fastened the electrodes of the state's portable electric chair to her skull and legs. Ten minutes later, she was dead.

Her photograph in a newspaper depicted an attractive, slender, 26-year old brunette prostitute, who had spent the 18 months previous to Feb. 1940, soliciting in Beaumont's Crockett Street "red light district."

Following a brutal murder, she was sentenced to death, but people could still barely contemplate that the "tiger woman's" heart was as cold and callous as a cannibal.

Annie Beatrice Henry, born in 1916, was a product of the Great Depression, born into poverty, with only a 6th grade education, and so family-abused that the ran away at age 13 and became a hooker.

While still in Beaumont, she married Wayne "Cowboy" Henry, who later was a Texas convict. "...He was the only man that ever treated me decent," she once exclaimed.

Her crime was committed in Feb., 1940, when she and an acquaintance, Horace Burks, flagged down a ride to Orange at the old Neches River steel bridge on Hwy. 90. At Orange they flagged another ride with J. P. Calloway, a Houston traveling salesman, who was driving a new car.

As the trio approached Sulphur, the "tiger woman" pulled a small revolver from her purse and ordered Calloway to drive into a nearby rice field. She then ordered him to disrobe, and as he kneeled in the rice paddy, begging for his life, she fired one shot into his head.

She then ramsacked the

cash money out of his pocket-book, and the murderers fled eastward in Calloway's car.

Luckily Calloway's body was quickly discovered, and an all-points bulletin was issued for the missing car. A few days later, the couple was captured in the car; was returned to Lake Charles, where she and Burks stood trial for capitol murder, and both were sentenced to death as a result of her confession.

Nevertheless 33 months elapsed before her date with death. She received three reprieves from Gov. Sam Davis; and twice her case was reviewed by the Louisiana Supreme Court. When no reprieve was forthcoming on the morning of the 28th, Toni Jo knew that "she had to ride Old Sparky" (die in the electric chair) at noon.

Father Richard stood by her side throughout the ordeal. She was received into the Catholic Church, where she obtained solace and abtution as a result of her confession. Earlier they had cleaned and pressed her black crepe dress, which she then put on, and she cried as they shaved her head.

A week earlier, Toni Jo's husband, "Cowboy" Henry, escaped from a Texas prison farm, with intent to help her break out of jail. However, it was an exercise in futility for him, for two days later "Cowboy" was recaptured in a Beaumont flophouse.

Toni Jo, only the second woman ever to be executed in Louisiana, walked stoically to her death, sat down in the chair, and replied "No," when she was asked to offer a last word. Later she was buried in Lake Charles' Orange Grove Cemetery on Broad Street.

## Cameron Outdoors

### DUCK SEASON

Hunters have been waiting to see what the La. Wildlife and Fisheries Commission would decide on our regular duck season for the 2005-06 season.

The tentative date set by the Commissioners was a 60 day split season for waterfowl and other migratory species.

The 60 day season, six ducks per daily bag limit was set, but this has to be approved by the U.S. Fish and Wildlife Service, for the final say so. If this stays intact, this will be the ninth year of the same season and bag limit. Some say they change every ten years, and if you remember the point system of 100 points, it was 10 years long.

The western zone dates are: Nov. 12 through Dec. 4 for the first split and Dec. 17 through Jan. 22 for our second split. The east zone has different dates.

Bag limits of no more than 4 mallards (only 2 females), 1 pintail, 1 black duck, 3 mottled ducks (summer mallards), 2 wood ducks, 2 scaup, 2 redheads to make up a 6 duck limit. The daily bag limit for mergansers is 5, but with only one hooded merganese. Scaups have declined in population; that's the reason of only two per day.

The daily bag limit on coots (pool-do) is 15.

The regular goose season statewide is 72 days, Nov. 12 through Dec. 4 and Dec. 17 through Feb. 3. The daily bag limit on snow-blue and ross geese is 20 and white-fronted geese (speckle-belly) is two daily. The "Conservation Order" season where you can use unplugged guns, electronic calling and no bag limit will run from Dec. 5 through Dec. 16 and Feb 4 through March 12.

### BASSMASTERS CLASSIC

Many local bass anglers were keeping up on the Bassmaster Classic held in Pittsburg, which was shown daily on ESPN. Lots of us, while fishing Florida Lakes, took on "chatta" about our bass from the marsh averaging one pound at lots of club weigh-ins.

If you kept up with the classic, it's our turn to laugh, as Kevin Van Dam won the three day event with 11 bass, only weighing 12 lbs., 15 ozs., which is an average of 1 lb., 2 ozs., per fish. Second place was 12 bass-12.9 weight. Twenty-fifth place was 4 bass with 3.15, less than a pound each.

### GIBBSTOWN DOGFIGHT

Week 16 of the Gibbstown Dogfight had 9 boats entered. Tom Hess had three bass weighing 4.69 to take first place while Ricky and Rica Canik had three bass weighing 3.3 pounds for second place. George Melancon and Walt Richard had the largest bass of 2.75 pounds.

Tough fishing conditions produced light stringers. Walt Richard caught his team's largest bass of 2.75 pounds on a top water frog.

Week 17 of the Gibbstown Dogfight had six boats

entered. Conditions continued to be tough for anglers again last week. Darren Richard and Todd Conner eventually landed enough quality bass to take top honors last week. Todd caught the largest bass of 2.36 pounds on a grape/pearl worm in the Big Burns. This winning stringer of three bass weighed 4.8 pounds.

### LEMESCHE BASS CLUB

The Lemesche Bass Club will fish their final club tournament on Sunday, Aug. 28 out of the Old Amoco Field. Weigh-in is at 3 p.m. This is down to the line as the top five anglers are all in the 40 point standings. Richard Duhon is still in the lead with 45.18 points followed by Todd Morales with 43.06.

The club will hold their last club meeting on Wednesday, Aug. 31, at the Creole KC Hall. The reason for a week earlier meeting is dove-deer-alligator-teal seasons, will start in September and many of our anglers will be busy to prepare for the sason.

Lynn Khoury won the speckle trout (8.10) for the month of July for the CCA's tournament.

The 20th annual Alligator Festival is scheduled for Sunday, Oct. 2 at the Grand Chenier State Park.

The hunters who can hunt and bag Canadian Geese (ring-necked) has a season set for Jan. 14-22, with 1 daily and 2 possession limit. Hunting area excludes portions of southwestern parishes. A special \$5 permit is required.

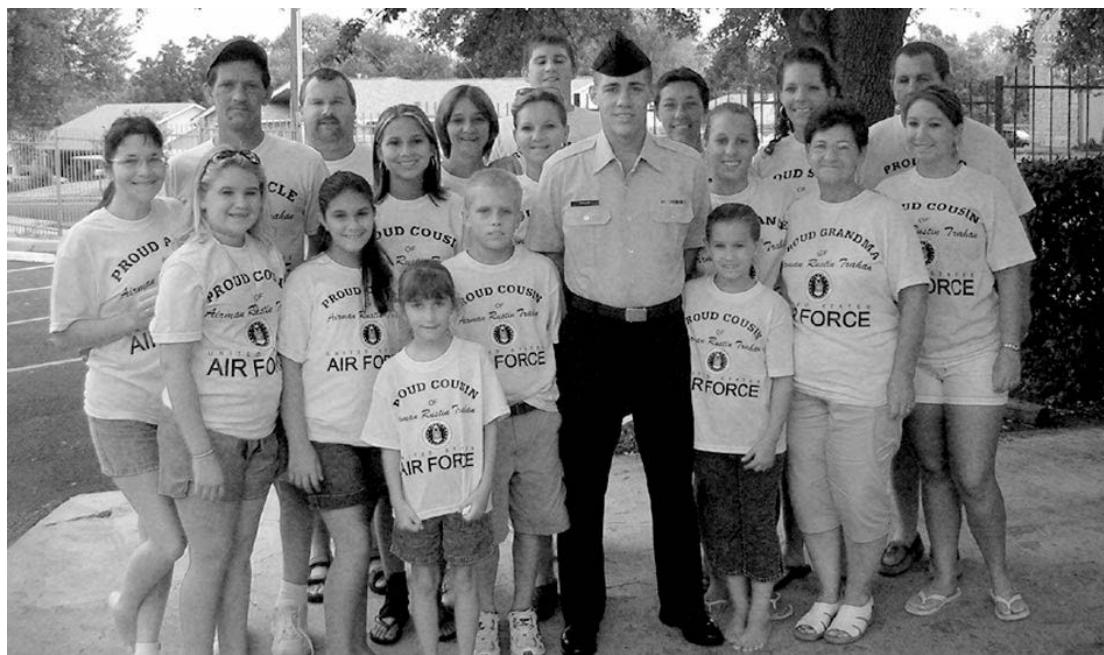
The 70 day rail statewide season: Sep. 17-25 and Nov. 12-Jan. 11. Bag limits king and clapper rails, 15 daily in aggregate, 30 in possessions. Virginia and Sora rails 25 in aggregate daily and possession limit.

Gallinules-70 days statewide season: Sept. 17-25 and Nov. 12-Jan. 11. Bag limits: 15 daily, 30 in possession.

Snipe-107 days statewide season: Nov. 5-Dec. 7 and Dec. 17-Feb. 28. Bag limit: 8 daily, 16 in possession.

Extended Falconry season-107 days: for ducks, rail and gallinules. Statewide season: Sept. 17-25 and Nov. 5-Feb. 10 Daily limits apply for each species. Falconry is the art of training falcons to hunt game and is a sport of hunting with falcons.

## SHRIMPERS READY TO COMBAT GERMAN U-BOATS

Ready to go to war in the campaign against Axis raiders in the Gulf, the sturdy Louisiana shrimping fleet, which brings an annual 100,000,000 pound catch here, has offered its several thousand craft to the United States Navy to aid in the anti-submarine campaign.

Far from being kept in their home ports by submarines operating against shipping, the keen-eyed skippers of the Louisiana trawlers are anxious to do more than catch the elusive crustaceans fancied for cocktails and salads.

The trawlers many miles out in the Gulf have heard torpedo blasts and are credited by the Navy with effective rescues of ship survivors and doing valuable salvage work.

One vessel was sunk by a submarine which never surfaced almost in the midst of six or eight fishing luggers and the 15 survivors were taken to a coast port by a member of the fleet.

## WATER DISTRICT PLANNED

The Cameron Police Jury has given notice that it intends to create a water district for the eastern portion of the parish, including parts of the Wards 1, 2 and 3 and the communities of Grand Chenier, Little Chenier, Chenier Perdue, East Creole and Oak Grove.

Parish Engineer George Bailey said that the fresh water level was falling in the Grand Chenier area, which will provide future problems for residents and also for plants in the area.

The proposed district would start at a point near the Sells property on the Front Ridge road, run to the east parish line, then north to a point north of the Intracoastal Canal and then east to just east of the present Creole water system.

Bailey said that a well and tower probably would be located in the Little Chenier area.

## HURRICANE ROUTE NEARER REALITY

The Cameron hurricane escape route is expected to be nearer to reality following a trip to Washington next Monday by two local officials. Rep. Conway LeBleu and Jerry Jones, police jury secretary, will meet with Interior Department officials to get their final approval for the route that the road will take through the Sabine National Wildlife Refuge.

The parish will offer two alternate routes: one that will follow the levee along the east bank of Calcasieu Lake, the other to cut across a portion of the lake on a raised causeway.

The estimated cost of the road is \$12 million and the

state legislature has already approved the sale of bonds to finance the work.

The proposed route would leave Hwy. 27 several miles east of Cameron near the Garber Subdivision and run straight north along the east bank of Calcasieu Lake joining the present highway west of the Sweetlake pontoon bridge.

The route could cut many miles off the distance between Cameron and Lake Charles and would provide a safe route for evacuation in case of a hurricane.

## CAMERON PARISH IN 1920

A glimpse at Cameron Parish in 1920 shows a population of 3,952, paying a total state tax of \$17,481.04 and a total local tax of \$73,000.23 (taxes levied for year 1919). Road bonds had been issued from January, 1919, to February 28, 1920, in the amount of \$330,000.

The following data is based on the 1919 reports: total acres planted in rice, 6,011, with a yield of 9 bags to the acre; 1,784 acres of pasture land valued at \$15 per acre; 1,570 hogs; 586 horses; 156 mules, 21,895 head of cattle; 540 sheep; 15 goats; 20,165 chickens.

In the parish by the beginning of 1920, there were 80 automobiles, no tractors, one sweet potato curing plant, and five operating cotton gins.

In 1920 Cameron Parish was without electricity, natural gas, telephone service, high schools, public libraries, banks. No roads led from the southern part of the parish to the outside world. All of these benefits have come in the last half century.
