## **Generators may be** available to businesses

with its regional and state allies has announced the availability of generators purchased through the state for issuance to essential service providers including grocery stores, pharmacies, service stations and other industry sectors.

Any major employer in the parish who would like to get in touch with the Louisiana Department of Economic Development (LED) is encouraged to contact the Office of Planning and Development at 775-5206 for referral for preliminary clearing and ultimate referral to LED.

In working with its economic allies around the State, LED has established the economic impact of hurricane Gustav to be as follows:

The Office of Planning & Excluding assets in the Gulf Development in conjunction of Mexico, the preliminary estimates suggest that Hurricane Gustav caused very roughly \$7-15B in property damage in Louisiana (including both insured and uninsured losses), including \$4-9B for homes, vehicles and personal property, and \$1.5-3B for commercial structures, property, and inventory (specific estimates for agriculture, timber, fisheries, flooding in North Louisiana, public facilities, and public infrastructure in process)

In addition, Louisiana businesses have incurred roughly \$1.5-2.5B in lost economic activity during the primary evacuation period (including two days prior to and after landfall) and will

## **Refuge tells** ciosure

The 125,000 acre Sabine National Wildlife Refuge will be closed to all public access and recreational uses as of 3:30 p.m. Wednesday, Sept. 10. For the safety of the public and the refuge employees, all the refuge entrance gates will be closed at 3:30 p.m.

This action corresponds with a Cameron Parish decision to implement a mandatory evacuation for lower Cameron Parish and areas prone to flooding. The refuge will re-open when the Parish lifts the mandatory evacuation and it is determined safe to re-enter Refuge marshes after the storm passes and damages, if any, assessed.

For duck hunters who were expecting to teal hunt on the Sabine Refuge this weekend you will not be allowed to access the Refuge however, the Lacassine National Wildlife Refuge will be open in accordance with Refuge specific and appropriate state, and federal regula-

A mandatory evacuation of lower Cameron Parish including low lying areas of Grand Lake, Big Lake, and Hackberry, was called at 10 a.m. Wednesday, with road-blocks scheduled to go up on Friday morning.

Emergency Preparedness Director Clifton Hebert, noted that the predicted path of the storm is very similar to that of Hurricane Rita in 2005, including the uncertainty level.

He said that he hoped the evacuation would prove unnecessary. "Hopefully I'll get a lot of phone calls on Monday," he said, "but your life is the most important thing.

Hebert pointed out that the projections for Ike have changed every day since it began, and on Tuesday were still fluctuating along the Texas coast. Roger Erickson of the National Weather Service said a difference of only 100 miles to the north could increase the storm surge at Cameron from 5-6 feet to 10-15 feet.

your property," Hebert said, just please, please don't take this lightly.

In 2005, many Cameron Parish were lulled into complacency by predictions that Hurricane Rita would strike Corpus Christi, Tex, giving Cameron Parish only 4-5 feet tides. After leaving with only a few belongings, evacuees were horrified to watch as the path moved further north daily, finally striking near the Texas-Louisiana border and virtually wiping out the Cameron coast.

Wednesday, AsHurricane Ike was projected to hit almost the same spot on the Texas coast. The National Weather Service was saying that the final landfall would depend on how soon a trough of low pressure moves in from the west, weakening the high pressure area protecting the Louisiana coast. It was the same for Rita.

There is rhyme to our reason for calling this mandatory evacuation on Wednesday," Hebert said. "People couldn't get a lot out in one day for Rita. We're "We'll be there to protect giving 2-3 days this time."

## What's the difference between mandatory and voluntary?

What is the difference between a mandatory and voluntary evacuation? When do you have to be out of the parish? The Sheriff's Office fields hundreds of these questions every time an evacuation is called.

Clifton Hebert, Director of the Cameron Parish Office of Homeland Security and Emergency Preparedness, says there is not a lot of difference between voluntary and mandatory. He would prefer to use the term "evacuation" every time. The main difference is that "mandatory" triggers some industries to close down operations and let employees go home. It also conveys a sense of urgency to residents that they really need to prepare to leave.

In a mandatory evacuation, no one is forced to leave, but anyone who chooses to remain should know that emergency services will not be available for them during the emergency.

It is possible that the Sheriff's Office, ambulance services, fire departments, and OEP staff will evacuate to higher ground for safety, leaving any die-hards stranded by rising water and cut off from medical care. No one will be coming to get them if things go wrong.

Most water districts will cut off water before leaving to keep tanks full. This pro-

cedure is credited with saving the water towers in Rita. Electricity will not be cut off, except by weather.

Roadblocks are set up at the entrances to the parish to prevent anyone who has no business here from entering. Hebert has stressed that residents can leave at any time, but at some point it will not be possible to re-

enter. Mandatory evacuation does not mean that everyone has to exit the parish at the moment it is called. The beginning time starts a countdown to final shutdown, which can take 1-2 days. Livestock owners can still make multiple trips to move stock. Homeowners can make extra trips to move belongings. Weather conditions will determine when re-entry is halted, Hebert

After landfall occurs, essential personnel will reenter the parish first, to clear roadways and assure safe re-entry for residents. Industry personnel will make sure there are no gas

leaks, etc. Electrical workers will remove downed power lines. Road crews will clear roads of trees and other debris. When all is safe, residents will be allowed to re-enter.

## Cyndi gets a close view of storm's damage across La.

Cameron Parish was spared from Hurricane Gustav, but like many others, Paul and I have family in other, more affected parishes. Our daughter Alyssa had flown in from Portland, Ore., to help us evacuate, and as soon as we returned from Houston, and I sent my articles to the Pilot, we set out for points east.

First stop - Abbeville. Paul's dad lives there. He is almost 91 and lives alone. We arrived to find he had been busy hauling limbs that had fallen from his pecan tree to the street. He wanted to leave the boards on his house in case Ike threatened, so there was not much more we could do for him.

Most of Abbeville seemed to be OK, with a lot of limbs on the ground, but no noticeable damage. The power had been out for less than a day, we heard from relatives.

Next stop - Broussard. My mother, Marianna Primeaux, lives there. She and her husband Wallace were without power for several days, but by the time we arrived on Friday it had been restored. A large magnolia tree in the back yard had split, but the house was not damaged. A neighbor had helped rake up leaves and pecans from the front

yard. We did see a large tree all damages seemed light. Alyssa and I helped Mom pull weeds and then headed east once more.

Along the way, we looked for damage. Most of Louisiana's economic-driven firms experienced relatively minor impacts from the storm, with the manufacturing sector experiencing the greatest loss of economic activity and productivity (roughly \$500MM and \$100MM, respectively, to date)

Shut-in oil-and-gas production in the Gulf of Mexico (and lower production rates as operations are restarted) could result in a loss of \$2-5B over a six-month period. The daily loss of revenues from shut-in operations (currently nearly 90-95% shutin) are ~\$150-200MM

Excluding the Gulf of Mexico, property damage from Hurricane Gustav appears to be about 7-15 percent of that from Hurricanes Katrina and Rita (roughly \$100B together)

The primary remaining economic threat from Hurricane Gustav is business interruptions across the which are being caused by a lack of electricity, fuel, and employees roughly \$150-250MM per day of GSP currently is being lost due to business interrup-



## **Evacuation to S. Carolina told**

By COOT MCINNIS

Aug. 29, my daughter called and said we best not stay because of the storm. She had been watching the Weather Channel and was getting concerned. My mother is 88 years old and my son is 28 years old, they both face daily challenges with their health. Hurricane Gustav was heading our way so we decided to leave before we were told to get out. Hurricane Rita taught everyone a valuable lesson, don't wait and don't stay.

The best place I could think of was at my aunt's in South Carolina. A long trip but I would have my mom and my son out of harms way. My brother decided he would go with us also.

I have a Jack Russell Terrier and my brother has a Yorkie, they both made the trip also. Jack was in his kennel and Bear was on his pillow. Overall the dogs did

My oldest sister came down from Houston on Saturday and we went to see my brother's first grandson. When we got home, I laid down. This was normal, my motto was whatever time I wake up, be in the vehicle we were leaving. We left at 5 p.m. on Aug. 30.

Upon our journey, we encountered areas of heavy traffic. We took 171, all along this route the gas stations

either had long lines or no gas. We stopped in north Louisiana.

The trip, I drove straight through took almost 24 hours which it has never taken me this long before. My aunt and family were waiting on us. They had been watching the Weather Channel also.

For the next few days we watched the weather channel and prayed. I didn't see to much about Cameron Parish because once again the Weather Channel and other stations were focused on the New Orleans area, as they were when Hurricane Rita changed all of our lives. received a text message from Cameron's Alert System. Family and friends kept in touch by cell phones.

brought Cameron Pilot with us, so my aunt could read some of the articles in it. She wanted to take a picture in front of the town my aunt lives in, Moncks Corner, S. C.

When I received the notice of the evacuation lifted, I delayed one day before returning. Once this happened, as it was when we left, you just don't know what area is without any power and what stations would be open for gas. My daughter who lives in Lafayette advised they had a lot of damage and power outages. My son would be staying with her to help with the

We started our journey home, on Wednesday Sept. 3. We stopped for lunch that ended up being supper at my niece's in Columbus, Ga. We took the scenic route before going to their home. We stayed at a motel Montgomery, Ala. encountered quiet a lot of Louisiana and Texas residents who were going back home. We came back on 80 then 20 and 49.

We saw part of the destruction that was left. In Louisiana we went through several parishes still without One station, a power. Chevron had power but the owner said his home had no water. He said he was tired of sponge bathing and was going to find a bathtub.

One station had no power, as it was also a convenient store that was also closed. It appeared that residents who were returning, left their trash there. Some was in trash cans but most was piled up by the gas tanks. This was not a pretty site, the owner and workers would face upon returning.

Once we got to Lafayette, my daughter met with us and took her brother home to start their recovery process. We got back on Interstate 10 and came home.

I brought my family over one thousand miles, to safety. When we left, my aunt's family were facing decisions of their own to stay or go. Hurricane Hannah was coming towards the coast of the

We are home and safe and watching Hurricane Ike.

## **Evacuation** aid may be available

The Department Homeland Security's Federal Emergency Management Agency (FEMA) has activated procedures under its transitional sheltering initiative that allows eligible Gustav evacuees who cannot return to their homes to stay in hotels or motels until it is safe for them go home. FEMA will pay for the lodging through the use of an authorization system directly to hotels and motels. A list of participating hotels is available online at www.gustav-evac.com.

As congregate shelters begin to close down, this assistance is intended to provide a more appropriate extended sheltering environment to evacuees who cannot return home because their neighborhoods are inaccessible or because their homes are so severely damaged that they cannot live in them. The initial period of assistance is from Sept. 3, to Oct. 3. FEMA can extend the stay if needed. Applicants are responsible for their own meals and hotel expenses other than lodging, as well as for any lodging costs above the authorized allowance.

Evacuees first need to apply for federal assistance through FEMA either online at www.fema.gov or by calling the FEMA toll free number at 1-800-621-FEMA (3362), TTY 1-800-462-7585. Eligible evacuees must fit the following criteria:


• FEMA must be able to verify the identity of the evacuee;

• The primary residence of the evacuee must be in one of the parishes that have been declared a disaster area (please, contact the toll-free number to be certain); and

• The evacuee cannot return to or re-occupy his/her primary residence.

Persons who do not meet these criteria will be referred to local agencies for possible assistance for short-term lodging.

This program will not reimburse applicants for previously incurred expenses. However, applicants should contact FEMA to see if they are eligible for such reimbursement under



## **School Board adopted** annual budget Monday

By CYNDI SELLERS

The Cameron Parish School Board adopted its annual budget Monday afternoon, planning to spend \$29.5 million in 2008-2009. This amount is \$2 million more than the expected revenues of \$27.5 million. The extra expense is not a problem, however, because the School Board has a beginning fund balance of \$42.7

The fund balance is made up of funds held in accounts such as the 16th Section fund, Special Projects fund, leftover bond issue funds, and other separate accounts for specific purposes, as well as previous year surpluses held in investments.

The Board approved raises for hourly workers, to reflect greater than minimum wage for all employees. Superintendent Stephanie Rodrigue said the raises were needed to stay

School clerks, bookkeepers, secretaries, paraprofessionals, janitors, sweepers, and food service technicians will receive \$8 per hour worked. ## Seven plan changes added to Police Jury agenda

By CYNDI SELLERS

Darryl Farque is angry and he's not going to take it any more. At Monday's Police Jury meeting the Big Lake juror made it clear that contractors and engineers can no longer submit plan changes at the last minute expect automatic approval.

Seven plan changes were presented to be added to the agenda, and Farque was prepared to disallow all of them, until he was persuaded to take them up one at a time on the agenda. New state rules require a unanimous vote to add any items to a published agenda.

Farque's concern was with plan changes to hurricane recovery projects in lower Cameron Parish, including the Cameron Multipurpose Building, East Annex, Cameron, Grand Chenier and Muria fire stations, Jetty Pier, and Cameron Maintenance Barn.

These items, mostly the addition of test pilings, were not brought before the agenda meeting for discussion, and Farque wanted assurance from Royal Engineering that FEMA would cover the cost of the changes. Royal has been hired by the parish to oversee FEMA projects to assure full coverage.

An engineer representing one of the firms involved said that the determination of need had only been made recently, but that waiting for the next agenda meeting would delay the projects. Royal's representative said the test pilings are considered necessary and FEMA will cover them. Other items were hazard mitigation requested by FEMA.

All the plan changes were eventually approved after a thorough discussion of each lower Cameron Parish item. Three Grand Lake water system plan changes were approved without discussion, upon Farque's assurance Community Development Block Grant funds would cover them.

Another extended discussion involved approval of the contract with Lonnie Harper and Associates for engineering services for the Holly Beach Sewer System. The contract is to be paid through state capital outlay funds, but the state will only allow for one day of inspection per week. Harper and Associates feel that daily inspections will be necessary when construction begins, and asked the Parish to cover the remaining \$63,000 needed for this. Jurors decided to wait until the construction phase actually begins and work with the state to get the inspections fully funded.

Farque complained that Harper and Associates didn't come before the Jury to present the contract, even though the company has not had to do so for any other contract with the parish. He warned that there will be much more scrutiny in the

Funds are currently available to proceed with aerial photography of the Holly Beach area for the engineering phase. Parish Planner Ernie Broussard also said the photos would be useful for coastal protection efforts later on. The photography was approved.

Broussard's report on the Planning and Development department's activities included plans to advertise the West Cameron Port on KPLC Salutes and progress toward getting roads in the north part of the parish resurfaced with Cheniere PILOT funds.

Lower Cameron Parish roads are to be resurfaced using CDBG funds. Funding for the West Police Jury Annex land acquisition and construction is waiting on written acceptance from the Office ofCommunity Development.

Parish OEP Director Clifton Hebert reported plans to call a mandatory evacuation on Wednesday at 10 a.m. for Hurricane Ike. He said he fully understood that people might wait to see where the storm is going, but he wanted to be ready. He had already requested generators and National Guard troops for roadblocks.

Hebert warned that a Category 3 storm making landfall close to Southwest Louisiana would trigger evacuations in Calcasieu, Allen, Beauregard, and Jeff Davis parishes as well. Shelters are being prepared in SE Louisiana, and buses in Lake Charles will transport those who can't afford to travel or are unable to do so

Hebert also explained that Cameron Parish didn't have enough damage from Gustav to qualify for FEMA assistance to residents. He said FEMA won't reimburse the first 3-4 days of an evacuation; it only kicks in when evacuation is prolonged by damage.

#### OTHER BUSINESS

Bids were accepted for elevation and resurfacing of a section of Little Chenier Road, a pumper truck for Fire District #14, geotechnical engineering for three library sites, and aluminum and plastic culverts.

Permission was given to advertise for road work in the north part of the parish, to be funded through the PILOT bond issue. Cameron Fire District #1 will advertise for radio equipment.

The President was given authority to sign leases for the West Cameron Ship Channel Boat Launch, the Calcasieu Pass Boat Launch, and a Waterworks #9/Fire District #9 agreement.

Two Holly Beach Sewer actions will move the project forward - a cooperative endeavor agreement/request for line of credit with State Facility Planning and Control and the Lonnie Harper and Associates contract for engineering services. The fee curve approved for the firm was the lower, architectural curve, rather than the engineering fee curve the firm could have

Charles Glenn Theriot was re-appointed to Fire District #9; Kurt Storm was appointed to Waterworks District #10; Patrick Theriot was appointed to Recreation District #6, replacing Lisa Stewart, who resigned; and Mitchell Kelley was appointed to Mosquito Control, replacing Whitney Baccigalopi, who resigned last month.

## **Facilities battened down and** everything out by Tuesday night

Within 24 hours of welcoming students back from Hurricane Gustav evacuations, plans were in place to make the move again. Without the advantage of the meeting day when packing was done for Gustav, school employees and community volunteers worked quietly and swiftly without disruption to classes. With the strong possibility of an evacuation, students were sent home with half of their textbooks on Monday afternoon. After OEP Director

Clifton Hebert made the call on Monday night for a Wednesday a.m. evacuation, parents received My State alert notifications requesting that they make all efforts to have their students in school on Tuesday, but with the understanding that schools would close Wednesday and remain closed until further

notice. Minutes later, Cameron Parish School Board employees received notifications to report to work at 6 a.m. on Tuesday, if at all possible, and to plan to remain as late

as possible. By keeping non-

essential materials and sup-

plies packed, in 14 hours all

schools were again emptied of contents and the last of the Cameron Parish School Board vehicles secured in Oberlin, and Lumberton, Tex. by 9 p.m.

The Gustav experience and the Rita recollections helped to streamline the process. An additional feature in this evacuation was the printing and distribution to parents of the cumulative records of all students. These records would expedite enrolling students in any school, if they would be temporarily displaced to another area. Cameron Parish School Board will continue this

From this point forward, parents should expect to receive these records in the mail every summer. The documents should then be stored with all other important papers that families evacuate with whenever they are forced to leave their homes.

We learn and grow from our experiences, just like our students do", sums up Rodrigue, Stephanie Superintendent of Schools in Cameron Parish.

## Most mosquitos being bred are not West Nile vectors

Most of the mosquitoes being bred in the standing water left in Louisiana from Hurricane Gustav are not the kind that carry West Nile virus, according to LSU AgCenter entomologist and mosquito expert Wayne mosquito expert

"The situation now is leading to a proliferation of pest mosquitoes, such as the inland floodwater mosquito,' Kramer said. "These mosquitoes are not vectors of the West Nile virus.'

The mosquitoes that cause West Nile virus, such as the southern house mosquito, are still around, how-

"July and August are the peak season for the mosquitoes that serve as vectors for West Nile virus," Kramer

The southern house mosquito - the most important mosquito vector of West Nile virus in Louisiana - will come into people's houses at night, Kramer said. And this is a problem for people without power who are leaving

skin. The mosquito repellents should include DEET or picaridin, Kramer said.

Currently, mosquito control districts around the state are gearing up to provide some major mosquito protection. Kramer recommends that people contact their local parish govern-ment officials to find out the status of mosquito protection in their areas.

(b) At least fifty percent of the excess severance tax remitted to a parish in a fiscal year shall only be used within the parish in the same manner and for the same purposes as money received by <u>the parish from the Parish</u> Transportation Fund or its suc-

(4) The term "excess severance tax" shall mean the amount of severance tax remitted to a parish pursuant to the provisions of Paragraph (3) which is in excess of the amount of severance tax remitted to the parish for the fiscal year prior to July 1, 2009.

(5)(a)(i)(aa) Notwithstanding any other provision of this constitution, after deposit to a Bond Security and Redemption Fund as required in Article VII, Section 9 of this constitution, and the allocations required in this Paragraph, Paragraph (E) of this Section, and Article VII, Section 10-A of this constitution, beginning July 1, 2009, fifty percent of the revenues received from severance taxes on state lands in the <u>Atchafalaya Basin each fiscal</u> year, but not to exceed ten million dollars each fiscal year, shall be deposited by the treasurer into Atchafalaya Conservation Fund hereby created as a special fund in the state treasury. The money in the fund shall be appropriated to the Department of Natural Resources to be used exclusively to fund projects contained in the state or federal Basin master plans or an annual Basin plan developed by an Atchafalaya Basin Research and Promotion Board and other such advisory or approval boards, all of which the legislature shall create and provide for by law within the Atchafalaya Basin Program, or to provide match for the Atchafalaya Basin Floodway System, Louisiana Project, all as the secretary of the Department of Natural Resources shall direct.

(bb) The money in the fund shall be invested by the treasurer in the same manner as money in the state general fund, and interest earnings shall be deposited in and credited to the fund. All unexpended or unencumbered money remaining in the fund at the end of the fiscal year shall

remain in the fund. (ii) Of the money allocated in any one fiscal year, eighty-five percent shall be used for water management, water quality, or access projects, and the remaining fifteen percent may be used to complete ongoing projects and for projects that are in accordance with the mission statement of the state master plan. However, a maximum of five percent of the money allocated in any one fiscal year may be used for the operational costs of the program or the <u>department.</u>

Be it further resolved that on the official ballot to be used at said election there shall be printed a proposition, upon which the electors of the state shall be permitted to vote FOR or AGAINST, to amend the Constitution of Louisiana, which proposition shall read as follows: To provide an exception to requirements of first refusal by the owner prior to sale and certain procedures for declaration of property as surplus property, when property is taken for the public purpose of removal of a threat to public health or safety caused by the existing use or disuse of the property. ## Church teachings explicit on when life begins

#### By The Most Reverend Glen John Provost, D.D. **Bishop of Lake Charles**

A serious responsibility of a bishop is to insure the purity of teaching in areas of faith and morals (cf. I Timothy 4:16). These teachings must be in conformity with the universal and historic teachings found in Sacred Scripture and Sacred Tradition and defined by the teaching office of the Catholic Church. The beauty of Catholicism rests in part on its ability to be clear.

Recently there has been high-profile press given to arguments concerning when human life begins. I am concerned about clarity and any misrepresentation of consistent Catholic teaching. My remarks are made in response to numerous questions posed to me by good Catholics in our own Diocese of Lake Charles who are confused by glib citations of patristic authorities, such as St. Augustine, that life begins at some other time than conception.

In response, I would say:

1) St. Augustine, one of our most revered Fathers, lived and wrote almost fifteen hundred years ago; he did not see the world around him with the scientific perspective, as we know it

was the nature of the immortal soul and the human being; he approached this question primarily from the perspective of theology and philosophy;

2) To answer a question such as when does life begin, science gives us a quite adequate answer; according to one prominent embryology text, The Developing Human: Clinically Oriented Embryology, by Keith L. Moore and T.V.N. Persuad (7th Edition; Publ. Saunders, p. 16), "Human development begins at fertilization when a male gamete or sperm (spermatozoon) unites with a female gamete or oocyte (ovum) to produce a single cell—a zygote. This highly specialized, totipotent cell marked the beginning of each of us as a unique individual"; if he were alive today, St. Augustine would agree, because St. Augustine believed that there was no "disjunction" in what was known by faith and reason (cf. Catholic Encyclopedia, 1981 ed., vol. 5, p. 808, "St. Augustine" on "Faith and Reason"); life begins at conception; no doubt St. Augustine would have marveled at a uterine ultrasound and what it reveals about a human in the womb:

3) The teaching that life in the womb is sacred has been con-

reflected in the opposition of the Church for twenty centuries to abortion; please consult the oldest catechism instruction of the Church, outside the Sacred Scriptures, called the Didache or The Teaching of the Twelve Apostles from the First Century A.D.; it reads as follows: "Do not kill a fetus by abortion, or commit infanticide" (Didache, 2:2); also, noted patristic scholars are in agreement that St. Augustine probably knew the Didache and may have used it as a source in writing his own First Catechetical Instruction;

4) To say in some way that the Fathers and Doctors of the Church in centuries past taught otherwise than the Church's consistent teaching on the sacredness of life in the womb or that they were not sure when life began is misleading and erroneous; for this reason, the official Catechism of the Catholic Church states: "Human life must be respected and protected absolutely from the moment of conception... Since the first century the Church has affirmed the moral evil of every procured abortion. This teaching has not changed and remains unchangeable" (Catechism of the Catholic Church, #2270-

The recent gift of \$100,000 establishing the Msgr. Irving A. DeBlanc Burse was the largest single contribution made to begin a burse in the history of the Diocese.

A seminary burse is a permanent fund set aside to provide income for the education of seminarians. The principal of the fund is never spent but invested, with the interest used each year for seminarian education expenses. Since the principal is never touched, this fund is truly a "gift that keeps on giving." Donations made to the fund will continue to support the education of seminarians every year, as long as the Diocese exists.

Seminary burses can be started with any amount of money and gifts may be made to already established burses.

Some of the burses have been established in memory of other highly regarded priests, such as Msgr. Amos Vincent, Father Oris Broussard, Father John Giles and Monsignors Curtis Vidrine and Murphy J. Bernard along with Msgr. Jules Daigle, Msgr. Aloysius Van Buijtenen and Msgr. Louis H. Boudreaux.



## Catholic people called to stand with immigrants

WASHINGTON - In his keynote address to the National Migration Conference recently, Cardinal Roger Mahony said, "A human being's worth is defined by their God-given dignity, not by what papers they

Recognizing the general negative feelings toward immigrants, refugees, and newcomers, Cardinal Mahony described these times as a "dark moment in our nation's history" and challenged all Americans not to scapegoat immigrants for many of the challenges facing our country.

The Rev. Henry Mancuso, Secretary for Pastoral Services for the Diocese of Lake Charles, was one of eight representatives from Louisiana in a total of 700 who attended the four-day conference, which was sponsored by the United States Conference of Catholic Bishops, Catholic Charities USA, the Catholic Legal Immigration Network, Inc., and the Migration Relief Services.

The Catholic Bishops of the United States have called for Comprehensive Immigration Reform, which balances a nation's right to protect its borders and the right of all people to seek a place to live in which they can provide for their families while living without fear. It is often thought that the Bishops support an "amnesty plan"; but this is not true, according to Father Mancuso.

In their proposals, leaders of the United States Conference of Catholic Bishops have called for a "path to earned citizenship",

especially for the 12 million undocumented people already within our borders. To earn citizenship, undocumented men and women would need to pay a penalty for entering the United States without permission, apply for Social Security, pay taxes, and enroll in English classes.

Conference participants were given Biblical reminders of Abraham leaving his homeland under God's command to found a new nation. God brought the Hebrew Community from bondage in Egypt to a "promised land." Mary and Joseph were asylum seekers in Egypt because they feared for the safety of their child Jesus. We are a nation of immigrants who have been regularly renewed by newcomers to our shores.
