On a motion by Ernest Roberts and seconded by Jaimie Boudreaux, and carried, the Davy Doxey was elected pro tem chairman to preside over this meeting

pro tem chairman called the meeting to order at 5:30 p.m. at the Cameron Main Library. Board Members present were Davy Doxey, Ernest Roberts, Jaimie Boudreaux and Peter Posada. Thomas McDaniel and Beth Ferguson were absent.

The voluntary prayer was led by Jaimie Boudreaux and Ernest Roberts led the Pledge of Allegiance.

On the motion by Jaimie Boudreaux and seconded by Ernest Roberts, and carried, the minutes of the September 18, 2018 meetings were approved. There was no public comment.

On the motion by Ernest Roberts and seconded by Jaimie Boudreaux, and carried, the financial statement was approved.

On the motion of Jaimie Boudreaux, seconded by Ernest Roberts, and carried, the Board voted to accept the deletions.

On a motion of Jaimie Boudreaux, seconded by Ernest Roberts, and carried, the Board voted to accept the proposed 2019 Library Budget.

There being no further business and upon the motion of Ernest Roberts Jaimie Boudreaux seconded by Jaimie Boudreaux, and carried, the board voted unanimously to adjourn at 6:27 P.M.
